4. Enrolment Fee and Deposit

- An enrolment fee of R650 is payable for all new enrolments. This fee covers administration; your child's FasTrackKids backpack and shirt.
- For all pre-school enrolments, a refundable deposit of R 2,500 per child is due on enrolment and will be held in a non-interest bearing account. This deposit will be refunded when the child leaves the school provided all fees due are paid in full.

8. Sundry Charges

- Annual Stationery Fee: An annual stationery fee of R 650.00 will be included on the first invoice of the year.
- Ad-Hoc Fees: Although FasTrackKids attempts to keep additional charges to a minimum, there will be additional charges from time to time (e.g. outings, concerts, guest speakers, baker-man day, school photographs and fun days). You will receive information of any charges and the option to opt in prior to your account being debited.

9. Billing procedures

- Monthly Payments:
A debit order system administered by FasTrackKids Fourways (D-Vis Investments Pty Ltd) is the only way of making payments on the monthly payment option. Payments are due and debited on the 1st day of each month.
- Termly and Annual Payments:
Payment is due in advance on the first day of term for termly payments and the first day of the school year for annual payments.

FastrackKids Fourways (D-Vis Investments) reserves the right to restrict admission of any child in respect of whose tuition fees are not paid to date. All overdue payments will be handed over for debt collection and all costs will be for the account of the parent, guardian or responsible person/s.

12. Notice

In terms of the contract of enrolment signed, you are required to provide a full and complete terms notice in writing on or before the 1st day of term. Should a terms notice not be given, parents will be liable for a terms fees in lieu of notice.
